1. Introduction

The text must be in English. Authors whose English language is not their own are certainly requested to have their manuscripts checked (or co-authored) by an English native speaker, for linguistic correctness before submission and in its final version, if changes had been made to the initial version. This document you are reading is written in the format that should be used in your paper.

This document is set in 10-point Times New Roman. Major heading in 12-point, bold. Set your page as A4, width 210, height 297 and margins as follows [3]:

- Left Margin :0.65"
- Right Margin: 0.55"
- Top Margin: 0.7"
- Bottom Margin: 0.7"

Some technical formatting software print mathematical formulas in italic type, with subscripts and superscripts in a slightly smaller font size are acceptable.

2. Headings and Footnotes

Major headings should begin at the left margin in a bold font without underline. They need to be numbered. Usual primary headings are Materials and Methods, Results, Discussion or combined as Results and Discussion, Acknowledgement and References.

2.1 Subheadings

Subheadings should be as the above heading "2.1 Subheadings". They should start at the left-hand margin on a separate line, subheadings 11-point. The top of this paragraph illustrates a sub-subheading.

Title: The title should be centered across the top of the first page and should have a distinctive font of 16-points Century. It should be in a bold font and in lower case with initial capitals. Right below the title (separated by single line spacing) are the names of the authors. The font size for the authors is 11pt. Author affiliations shall be in 9 pt.

Keywords: From 5 to 6 keywords should follow the abstract (as a subheading: Key words, of the Abstract).

Illustrations or pictures: Place illustrations (figures, tables, drawings, and photographs) throughout the paper at the places where they are first discussed in the text, rather than at the end of the paper. Designate all illustrations, graphs and line drawings as figures and number them consecutively. A plate of drawings or photographs may be treated as one figure with letters for each element or as several figures with each figure numbered consecutively. All figures must have a caption placed below the figure (Figure 1). Figures should be designed properly to fit in single column (8.0 cm) or two columns (16.5 cm) width by 22.8 cm height.

Tables: All tables must be given sequential numbers (1, 2, 3, etc.) and have a caption placed above the table (Table 1). Place the illustrations/Pictures/Tables numbers and caption in 10-point font. Footnotes should be typed in singled-line spacing at the bottom of the page and column where it is cited. Footnotes should be rare.

EQUATIONS: If you are using *Word*, use either the Microsoft Equation Editor or the *MathType* add-on (http://www.mathtype.com) for equations in your paper (Insert | Object | Create New | Microsoft Equation *or* MathType Equation). "Float over text" should not be selected.

Number equations consecutively with equation numbers in parentheses flush with the right margin, as in (1). First use the equation editor to create the equation. Then select the "Equation" markup style. Press the tab key and write the equation number in parentheses.
